The undersigned hereby further agrees to abide by the "terms of adoption" listed below:

1) This animal is not to be a laboratory or classroom animal or is it to be used for research in any way.

3) The adopter agrees to provide proper nutrition.

4) The pet must be spayed or neutered unless there is a medical condition that prevents this surgery.

5) The adoptive owner agrees to promptly attend to all the medical needs of the pet.

6) The adoptive owner agrees to keep the pet currently vaccinated.

7) Once the adoption is final, the animal must not be sold, traded, given away to anyone, or relinquished to any shelter. If for any reason the adoptive owner is unable to keep the animal, it must be returned to Columbus Kitty Adoption Center

8) We reserve the right to inspect the home and reclaim the pet if, in our opinion, it is in the best interest of the animal.

9) We cannot be held responsible for any accidents, injuries, or destruction caused by the animal.

10) This animal has had an exam by a veterinarian. We will not be held responsible for any conditions for which clinical symptoms are not in evidence at the time of adoption. It is strongly that you take this animal to your own veterinarian within 7 days of the adoption.

11) If for any reason the adoption is not satisfactory to the adopting party, or the Adopter(s) fail(s) to comply with all the terms and conditions of this agreement, the Adopter(s) agrees to cooperate in the return of the animal.

12) If you rent, we will need your Landlords contact information to verify that you will be allowed to have a pet in your home.
